

1966-68 CANAVERAL SECTION NOMINEES FOR OFFICERS

Excerpts from the "Guidelines for Nominating Committee" from Canaveral Section Chairman L. E. Williams which were used by the Section Nominating Committee

may be of interest to Section members.

"I know you will nominate candidates who are active, capable, willing workers for the Section and who are representative of the various branches of engineering and companies within the Section." "Some of the desirable characteristics for candidates are listed in the letters sent out by Headquarters for IEEE service: demonstrated interest in IEEE; relevant experience in Section and Region work; relevant Group or Technical Committee work; a knowledge of the work and scope of the office; time to do the necessary work; adequate freedom and support for reasonable travel; office facilities for paper work; a reputation for prompt correspondence; and indicated willingness and availability to serve.

"In addition to these characteristics, I believe it is extremely important that all candidates for Section office be compatible as a team."

ARTICLE VII - NOMINATION AND ELECTION OF OFFICERS

Sec. 1. Section officers shall normally be elected at the May meeting. Installation of officers normally will be made at the conclusion of the Annual meeting in June.

Sec. 2. The Nominating Committee shall announce nominations for Section offices no later than in the March issue of the Indian River Engineer and at the March meeting. The Nominating Committee may nominate more than one person for any Section office. Additional nominations may be made for any Section office by the Section membership, provided each such nomination is, (a) supported by a petition signed by at least ten voting members of the Section, and (b) the petition is submitted to the Section Chairman prior to the May meeting, at which time the nominations shall be closed. Each nomination made by a petition which is submitted in time for publication shall be announced in the May issue of the Indian River Engineer.

Sec. 3. When at an Election meeting in May there is more than one nominee for any one of the Section elective offices, the Chairman of the Section shall conduct a secret ballot election if there is a quorum of the membership in attendance (15 members). If there is not a quorum, the Chairman shall announce that the election will be determined by a letter ballot to be taken as soon as possible, or the election may be postponed until the June meeting. The Chairman shall choose the procedure to be used in consummating the election.

Sec. 4. In the event there is no contest for any office, the election for that office shall take place at the May meeting even though a quorum of the membership (15 members) is not present.

REPORT OF EXECUTIVE COMMITTEE MEETING

The last Executive Committee Meeting was 11 Jan. and the following items were among those discussed.

Reliability Group may meet in April and June; the June Section Meeting it is hoped will feature the IEEE President; Section membership in Jan. was 978, a drop from the 992 in Dec. This drop included 33 resignations.

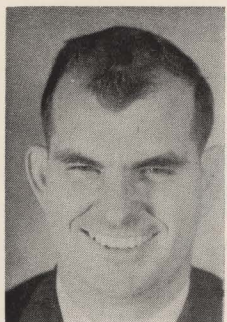
