TO ALL MEMBERS OF THE EXECUTIVE COMMITTEE:


A meeting of the Executive Committee of Central Illinois Section was held June 19, 1956 in Decatur. Present were Messrs. Schroeder, Shelton, Simpson, Williams, Noel, Griffith, Goers, Sangster, Marquardt and Kelley.

1. It was decided to hold nine meetings during the 1956-1957 season split as follows: 3 in Springfield, 3 in Decatur, 2 in Urbana, and 1 in Bloomington. One of the two listed for Urbana is a joint meeting with the Student Branch and the other is the Annual Meeting held in Allerton Park. It was further decided that all meetings this year would be dinner meetings. Rather than devote one entire meeting to a report from the Vice President of District 5, it was decided that a special invitation would be tendered to him by the Student Branch and by the Section to the joint meeting in Urbana in November.

2. Committee appointments were made in accordance with the attached listing.

3. The Chairman reported that he would be unable to represent the Section at the Section Delegates Conference in San Francisco. Mr. Dan F. Hang, Member at Large, was selected as an alternate and the Chairman was to check with Mr. Hang to see if he could attend. (Mr. Hang accepted this appointment and represented the Section in San Francisco.)

4. A committee on subsections was appointed by the Chairman consisting of J. W. Marquardt, G. E. Sangster and J. E. Williams. Mr. Marquardt will act as Chairman. This committee was appointed to recommend to the executive committee whether or not consideration be given to the establishment of one or more subsections.
