SUBJECT PETITION - IEEE NORWAY SECTION

The IEEE Bylaws Section 403.4 provides that "A petition for the formation of a Section shall be signed by not fewer than fifty members other than Students, having mailing addresses within the territorial limits proposed in the petition. Under special circumstances the Executive Committee may consider petitions bearing fewer than fifty signatures. The territorial limits of the proposed Section shall be specifically delineated in the petition. The petition shall also list the concurring and non-concurring Sections that are involved in the territory concerned."

IEEE Bylaws Section 403.4 provides as follows:

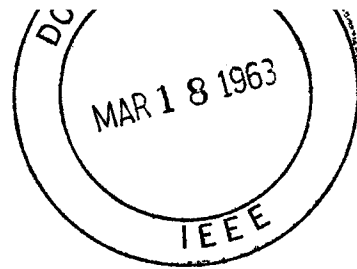
