- Zeb Burnett 11/9/61 - Suggests Section representatives discussion at WGM ..... Prefers Senior Member and Member to AIEE designation.
  
- Lin Holmes 9/21/61 - Merger not realistic ..... Liberal membership policy of IRE seems to go with greater sophistication and more advanced science..... ITG's supposed to grow naturally, not in keeping with AIEE policy of strict control ..... Management of AIEE should concentrate on serving the members rather than imitating and competing with IRE..... "Definition of Electronic Industries" enclosed.

Haggerty 9/2/61 - "Haraden Pratt and I have had long visits individually with John Tobin of IRE's law firm, Donoba, Leisure, Newton and Irvine, and Lloyd Berkner is visiting with him in New York today. Tobin particularly cautions on the probable desirability of retaining the corporate entity of one of the two societies rather than the elimination of both entities and the establishment of a new one. He so recommends for a variety of legal reasons, and this is no particular surprise to me since we ran into a similar situation in our business some years back. The tax status of both organizations must also be taken into careful consideration prior to any actual amalgamation."

In addition there is a deferred compensation contract between IRE and its Executive Secretary.
