## Power Quality Issues of Variable Speed Drives/Solid State Starter Applications

Under the auspices of IEEE-North Jersey PES/IAS Chapters there will be a technical presentation on "Power Quality Issues of Variable Speed Drives/Solid State Starter Applications" on May 19, 1999. The presentation will be given by Mr. R. Vittal Rebbapragada, P.E.

#### **About the Talk**

With the introduction of variable speed drives and solid state starters, selection and application of drive motors brought in requirements that were not required to be addressed when the drives were constant speed induction motors, built to NEMA MG-1. The issues that need to be addressed are: (1) Harmonics, (2) Transients in output current from PWM Inverters, (3) shaft voltage and bearing currents, (4) air gap flux. Knowledge of all these is necessary for proper application of this technology. As an example, does one need a 6 pulse, 12 pulse or 18 pulse system? This presentation will briefly address all these issues, and outline the requirements from already published ANSI/IEC Standards

#### About the Speaker

Mr. R. Vittal Rebbapragada, P.E., is employed by Raytheon E&C, Princeton, NJ as a Senior Consulting Electrical Engineer. Mr. Rebbapragada graduated with a BSEE from the Indian Institute of Science in 1959, and since has worked in Utility/Architect Engineering Firms in the areas of Generation, Transmission & Distribution. He is member of several technical committees of IEEE-PES, and a licensed professional engineer.
